2019 PEDESTRIAN COUNT

Background:

The 2019 count was taken in the city of Tauranga

Weather Conditions:

The weather on the day of the count in 2019 was fine with strong North Easterly winds.

Methodology:

The methodology is as follows:

- The 2019 count was undertaken on Wednesday 18th September in the traditional September pre school holiday period.
- Local PINZ members carried out the count, with most people covering two positions over a half hour period in the morning and afternoon. Count times are as follows:
 - Morning 10.30 am 11.00 am
 - Afternoon 2.00 pm 2.30 pm
- The count is on an 'electric eye' basis, and includes all pedestrians passing an imaginary line from the building frontage to the footpath edge.
- The morning and afternoon counts are doubled to achieve a reflection of one hour's traffic.

RESULTS. Top Ten Spots





2019 SUMMARY

The overall pedestrian count in the Tauranga CBD decreased by approximately 15%, with a total of 8,158 pedestrians in 2019 compared to 9,673 pedestrians in 2017. This continues a downward trend from the 2015 count which had a total of 10,940 pedestrians and reflects a decrease in 2017 of 11%. However, count locations 19 and 27 were inaccessible in 2019 due to construction work at the new Farmers Development. After making adjustments for these locations, the 2019 count reflects a modified decrease of 13% compared to 2017.

The results reflect a bleak outlook for the Tauranga CBD with retailers feeling the pinch of ongoing construction and lack of parking and city vibrancy. Confidence is being restored to the CBD with high levels of investment from both the public and private sector. However, any resurgence from these developments is likely a few years away.


